Participation in these sweepstakes is governed by the specific entry conditions stated in each individual case and by our present General Terms and Conditions.

## **General Terms and Conditions for Participation in JuCad Sweepstakes**

### **1. Scope**

- 1.1. These General Terms and Conditions (hereinafter “GTC”) apply to the participation in JuCad's online sweepstakes. JuCad offers participants the opportunity to take part in the sweepstakes offered by filling out a contact form.
- 1.2. By participating in the sweepstakes, participants accept the GTC.

### **2. Participation**

- 2.1. Only participants with a permanent residence, a minimum age of 18 years and a valid postal address are eligible to participate in the sweepstakes.
- 2.2. Participation in the competition requires the participant to register for the JuCad newsletter between July 1, 2021 and September 30, 2021.
- 2.3. Participation is free of charge and independent of any purchase of goods or services.
- 2.4. Participants in the sweepstakes must have internet access and an e-mail address. Multiple entries by using several e-mail addresses to increase the chances of winning are not permitted. To participate in the competition, e-mail address, first name and surname as well as postal code and city must be provided.
- 2.5. The legal representatives and employees of JuCad, as well as all persons involved in the implementation of the competition, their partners and family members of the aforementioned individuals are not eligible to participate.
- 2.6. By participating in the sweepstakes, participants agree to these Terms and Conditions for Participation.
- 2.7. Winners are selected at random and will be notified personally by JuCad in writing via e-mail. JuCad reserves the right to publish the winner's name on the JuCad website and in social networks. Participants agree to the publication of their name for this purpose.
- 2.8. Participants are responsible for the accuracy of the contact data provided. If the prize of the sweepstakes cannot be allocated correctly due to incorrect data, the participant's claim to the prize shall be forfeited.
- 2.9. Winners' prizes will be shipped by a forwarding agent selected at JuCad's discretion. Upon handover to the forwarding agent, all risks of accidental loss and accidental deterioration are transferred to the winner.

- 2.10. JuCad reserves the right to exclude participants who violate the Terms and Conditions for Participation or who attempt to influence the sweepstakes through technical manipulation. In the event of exclusion from the sweepstakes, prizes may be subsequently forfeited and reclaimed.
- 2.11. Cash payout of the prize is excluded. The prize is not transferable or exchangeable. Winners accept necessary variations of the prize due to circumstances beyond control of the companies involved in the sweepstakes. Legal recourse is excluded. Winners are responsible for any applicable taxation of the prize.
- 2.12. Winners will be notified of the prize by e-mail in October 2021. In order for the prize to be shipped, winners undertake to submit their full name, private address and e-mail address to the organizer within 7 days of receipt of the prize notification. If a winner does not contact the organizer within two weeks of being notified, the prize is forfeited without compensation. In this case, the organizer has the right, but not the obligation, to determine a new winner. The same applies if a winner does not accept the prize.

### **3. Privacy, Right of Revocation**

- 3.1. By participating in the sweepstakes, participants expressly agree that JuCad may store relevant data for the duration of the sweepstakes and exclusively for the purpose of the sweepstakes and in the event of being awarded a prize, JuCad may publish the winner's name and place of residence on websites operated by JuCad.
- 3.2. JuCad would like to point out explicitly that no data will be passed on to uninvolved third parties.
- 3.3. JuCad will only forward the winner's details to the company involved in dispatching the prize.
- 3.4. Participants are free to revoke their consent at any time and thereby withdraw from participation.

### **4. Modifications of Rules for Participation and Termination of Sweepstakes**

- 4.1. JuCad reserves the right to modify the Terms and Conditions for Participation at any time.
- 4.2. Furthermore, JuCad reserves the right to terminate or interrupt the sweepstakes at any time for good cause without prior notice. This applies in particular to such circumstances which might interfere with or prevent the scheduled course of the sweepstakes.
- 4.3. If such termination is caused by the conduct of a participant, JuCad is entitled to claim compensation from that individual for the damage incurred.

## 5. Liability

- 5.1. The information provided will be used to contact the winner and to deliver and process the prize. In addition, JuCad may contact participants by e-mail. Participants' information will not be shared with unauthorized third parties, with the exception of the companies involved in the sweepstakes.
